RE: 100% Report filed by Candidate Ginny Burdick

Ginny Burdick, Candidate for Position No. 2 at the May 16, 2006 Primary election, has filed a second "Nonparticipating Candidate 100% Report" with my office indicating \$154,885.31 in contributions to date. Ms. Burdick previously filed a 100% Report on April 27 indicating \$154,232.63 in expenditures to date.

A copy of the report is included for your reference and indicates contributions in the amount of \$154,885.31 and in-kind contributions in the amount of \$2,2845.06 to date. This report was received in my office May 1.

Ms. Burdick will now be required to file a "Nonparticipating Candidate Increment Report" with my office each time she receives contributions or makes expenditures in the aggregate amount of \$5,000. My office will forward any such notices to all candidates for Position No. 2 as required by City Code.
